FINANCIAL

- 2023-2024 Budget: Recurring expenses were generally in line with the budget, except we paid slightly more for web fees and insurance than budgeted.
- Budget for FY 2024-2025 is \$3145 expenses, \$6250 income and net capital reserve of \$5012. No dues increase will happen this year and annual dues will remain at \$125.
- We ended the fiscal year with all homeowners' current on their due's payments
